**JOINT RESOLUTION 17-02-03-17**

**A JOINT RESOLUTION APPROVING A LICENSE TO OPERATE  
WEWINABI, HEAD START AND EARLY HEAD START IN DISTRICTS  
I, II AND III**

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally- recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (a) and (d), the Band Assembly has the power to enact laws which regulate internal and external affairs of the Band in order to promote the general welfare of the people of the Band, and to adopt resolutions; and
- WHEREAS, pursuant to 4 MLBSA § 6, the Chief Executive has the power to exercise the executive powers of Band government; and
- WHEREAS, the Band Assembly acknowledges that a statutory amendment regarding the licensing of child care centers on Band Lands has been adopted by the Band Assembly on October 1, 2013 and such Bill is numbered 15-04-49-13; and
- WHEREAS, the Mille Lacs Band child care centers in Districts I, II & III had a license adopted via Joint Resolution 15-04-260-13 and 15-04-261-13 and such licenses expired on September 30, 2016; and
- WHEREAS, on October 3, 2016 the Licensing Committee recommends to continuing licensure of Wewinabi, Head Start and Early Head Start in Districts I, II and III; and
- WHEREAS, the District I Wewinabi has a capacity of Infants: 24-32; Toddlers: 72-84; Preschool: 98; and School Age: 35; and
- WHEREAS, the District II has a capacity of Infants/Toddlers-16; and Preschool-18; and
- WHEREAS, the District III has a capacity of Infants/Toddlers-8; and Preschool-18; and
- WHEREAS, the Band Assembly and Chief Executive approves a license for a period of one year to allow Wewinabi, Head Start and Early Head Start in Districts I, II and III to operate during this period of time beginning on October 1, 2016.




