JOINT RESOLUTION 18-01-131-18

A JOINT RESOLUTION APPROVING THE ENROLLMENTS INTO THE MILLE LACS BAND, MILLE LACS RESERVATION FOR THOSE WHO MEET THE 1/4 DEGREE REQUIREMENT OF THE MINNESOTA CHIPPEWA TRIBE

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBSA § 2(d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the Band; and

WHEREAS, pursuant to 4 MLBSA § 6, the Chief Executive is empowered to exercise the Executive Branch powers of the Band; and

WHEREAS, the Band Assembly and Chief Executive have reviewed the following applications for enrollment:

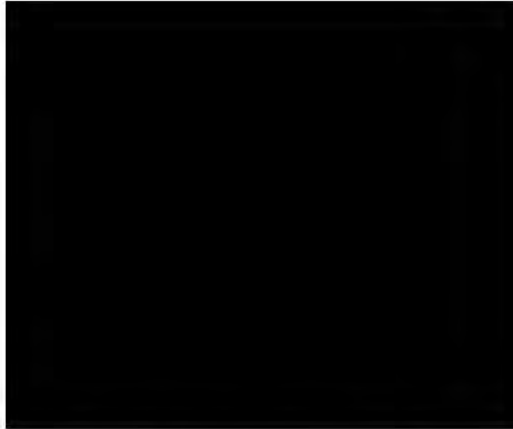

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly and Chief Executive approve the above applications for enrollment and approve all rights provided for Mille Lacs Band of Ojibwe, Minnesota Chippewa Tribe enrollees.


WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 19th day of April, 2018 at Onamia, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
