RESOLUTION 18-01-163-18

**A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED
BY RESOLUTION 14-03-35-11 FOR MILLE LACS BAND HOUSING
DEPARTMENT**

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution 14-03-35-11 authorized a residential land lease to Mille Lacs Band Housing Department for the purpose of obtaining a lease site; and
- WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows:

Part of Tract #410T001039, located in the North Half of the Northwest Quarter (N1/2 of NW1/4) of Section Twenty (20), Township Forty-three North (43N), Range Twenty-seven West (27W), Fourth Principal Meridian, Mille Lacs County, Minnesota, described as follows:

Lot One (1), Block Fourteen (14) of Bugg Hill West Plat.

Containing 1.0 acres, more or less; and

- WHEREAS, the lessee voluntarily relinquishes their land lease authorized by tribal Resolution 14-03-35-11 and requests this lease site revert back to the Band.
