**RESOLUTION 18-01-111-18**

**A RESOLUTION AUTHORIZING A LAND LEASE FOR RESIDENTIAL PURPOSES TO THE MILLE LACS BAND HOUSING DEPARTMENT TRACT 410T000199 AND 410T000202**

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, the Mille Lacs Band Housing Department respectfully requests a land lease for residential purposes; and
- WHEREAS, the lease will be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows:

That part of Tracts 410T000199 and 410T000202, being part of the Southeast Quarter (SE1/4) of Section Three (3), Township Forty-one North (41N), Range Seventeen West (17W), Fourth Principal Meridian, Pine County, Minnesota described as follows:

Commencing at the northeast corner of said Tract 410T000199; thence South 0 degrees 05 minutes 44 seconds West, bearing assumed, along the east line of said Tract 410T000199, a distance of 345.46 feet; thence South 46 degrees 19 minutes 05 seconds West a distance of 219.77 feet; thence North 43 degrees 40 minutes 55 seconds West a distance of 400.00 feet to the point of beginning of the land to be described; thence South 46 degrees 19 minutes 05 seconds West a distance of 200.00 feet; thence North 43 degrees 40 minutes 55 seconds West a distance of 200.00 feet; thence North 46 degrees 19 minutes 05 seconds East a distance of 200.00 feet; thence South 43 degrees 40 minutes 55 seconds East a distance of 200.00 feet to the point of beginning and there terminating.

Lease site contains 0.91 acres, more or less with 0.82 acres being located in Tract 410T000202 and 0.09 acres in Tract 410T000199.


NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly hereby authorizes a land lease for the property described herein for residential purposes be issued to the Mille Lacs Band Housing Department for a period of 25 years, renewable for an additional 25 years subject to the lease provisions, effective upon date of approval; and

BE IT FURTHER RESOLVED, that the lessee will utilize the land in conformity with the provisions of the lease within twelve (12) months of the effective date of the lease, and if all terms of the lease are not met, the land will revert to the Band; and

BE IT FURTHER AND FINALLY RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1<sup>st</sup> year anniversary of the effective date of the lease without the prior approval of the Band Assembly.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 10<sup>th</sup> day of April, 2018 at Minisinaakwaang, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
