RESOLUTION 17-04-76-18

A RESOLUTION APPROVING THE CONTINUANCE OF THE MILLE LACS BAND HOUSING INITIATIVE FISCAL OPERATIONS UNTIL JANUARY 30, 2018

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected governing body for the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBSA § 2(b) and (d), the Band Assembly has the authority to appropriate all Band revenue regardless of source, and adopt resolutions; and

WHEREAS, 3 MLBSA § 18 requires that all fiscal operations under the jurisdiction of the Band shall cease as of midnight on the last day of the biennium, unless the Band Assembly adopts a continuing resolution prior to such time; and

WHEREAS, Band Appropriation Bill 17-04-43-17, to fund the operations of the Housing Initiative for Fiscal Year 2017, expires September 30, 2017; and

WHEREAS, Band Assembly adopted 17-04-105-17 for said operations to continue to operate until December 31, 2017 since Fiscal Year 2018 budgets have not been approved; and


WHEREAS, the Band Assembly agrees to adopt a second continuing resolution until January 30, 2018.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorize the continuance of the Band Housing Initiative fiscal operations until January 30, 2018.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 28th day of December, 2017 at Minisinaakwaang, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
