**RESOLUTION 18-01-158-18**

**A RESOLUTION TO TERMINATE A RESIDENTIAL LEASE  
AUTHORIZED BY RESOLUTION 26-77 FOR MILLE LACS BAND  
MEMBER [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution 26-77 authorized a residential land lease with an attached mortgage to Mille Lacs Band Member [REDACTED] and his wife M.A. for the purpose of obtaining a lease site; and

WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon May 20, 1977, for the property described herein; and

WHEREAS, said land is described as follows:

Part of Tract 410T000074 described as the South 200 feet of the North 400 feet of the East 100 feet, of the SE1/4 of the NE1/4 of Section 28, Township 43 North, Range 27 West. Consisting of 1 acre, more or less.

WHEREAS, the lease is being terminated because the lessees are deceased, this lease site should revert back to the Band.

NOW, THEREFORE, BE IT RESOLVED, the Band Assembly hereby approves the cancellation of Resolution 26-77 and the termination of the residential lease authorized by said Resolution; and
