RESOLUTION 18-01-91-18

**A RESOLUTION MODIFYING RESOLUTION 12-01-111-06 AND
RESOLUTION 13-02-57-08 FOR MILLE LACS BAND MEMBER**
[REDACTED]

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution 12-01-111-06 authorized a residential land lease to Mille Lacs Band Member [REDACTED] with a mortgage for the purpose of obtaining a lease site; and,

WHEREAS, Resolution 12-01-111-06 also authorized that Lots 1 and 2, Block 1, Vineland Hills Addition be included with the original land lease for the property described therein for Casino Gaming purposes to be issued to the Corporate Commission of the Band; and

WHEREAS, Resolution 13-02-57-08 modified Resolution 12-01-111-06 to change the lease site for Mille Lacs Band Member [REDACTED]; and

WHEREAS, said land leased to Mille Lacs Band Member [REDACTED] is described as follows:

Part of Tract 410T001001, located in the North One-half of the Northeast Quarter (N1/2 of NE1/4) of Section Twenty (20), Township Forty-three North (43N), Range Twenty-seven West (27W), Mille Lacs County, Fourth Principal Meridian, more particularly described as follows:

Lot Forty-one (41), Bugg Hill Plat. The lease site is 1.0 acres, more or less; and


WHEREAS, Mille Lacs Band Member [REDACTED] does not have any unpaid mortgages.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly hereby approves the modification of Resolution 12-01-111-06 and Resolution 13-02-57-08 to remove the lease site for Mille Lacs Band Member [REDACTED] and authorize the cancellation of the lease for said lease site with Mille Lacs Band Member 410B007078, and all other terms and conditions shall remain the same; and

BE IT FURTHER RESOLVED, that the lease site for Mille Lacs Band Member [REDACTED] described above revert back to the Band.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 25th day of January, 2018 at Onamia, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
