JOINT RESOLUTION 18-01-96-18

**A JOINT RESOLUTION AUTHORIZING THE TRANSFER OF THE
RUTLEDGE PROGRAM FROM EDUCATION TO NATURAL
RESOURCES**

WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and

WHEREAS, on January 25, 2018 Commissioner of Natural Resources, Bradley Harrington, submitted a request to the Administration Policy Board and Band Assembly to transfer the Rutledge budget and program from the Education Department to Natural Resources with concurrence from Commissioner of Education, Rick St. Germaine; and

WHEREAS, the Band Assembly and Chief Executive have determined that it is in the best interest of the Band to transfer the Rutledge budget and program to the Band's Natural Resources Department.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly and Chief Executive approve the transfer of the Rutledge budget and program from the Education Department to Natural Resources.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 6th day of February, 2018 at Nayahshing, Minnesota by a vote of 2 FOR, 1 AGAINST, 0 SILENT.


