## JOINT RESOLUTION 18-01-140-18

A JOINT RESOLUTION APPROVING THE SUBMISSION OF THE GAA-ONIKAAMAGAK ZIIBAASKA'IGAN TO THE STATE OF MINNESOTA INDIAN AFFAIRS COUNCIL FOR THE FY19 DAKOTA AND OJIBWE LANGUAGE REVITALIZATION GRANT

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected governing body of the Mille Lacs Band of Ojibwe ("Band") a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Band Assembly and Chief Executive have established as a priority the improvement of spiritual, physical, mental, social and economic wellbeing of the people of the Band; and
- WHEREAS, the Band Assembly and Chief Executive recognize the need to protect and empower our children, parents, and elders in the continuing revitalization of our language, thus maintaining Tribal sovereignty; and
- WHEREAS, the Band Assembly and Chief Executive fully support the revitalization of the Ojibwe language as a vibrant, living, and thriving language throughout Minnesota; and
- WHEREAS, the Band Assembly and Chief Executive recognize that there is no cost sharing requirements with the submission.
- NOW THEREFORE BE IT RESOLVED that the Band Assembly and Chief Executive do hereby support the Gaa-Onikaamagak Ziibaaska'igan Program on behalf of the Band's Department of Natural Resources to the State of Minnesota Indian Affairs Council for the FY19 Dakota and Ojibwe Language Revitalization Grant Program.
