**JOINT RESOLUTION 17-04-11-18**

**A JOINT RESOLUTION AMENDING JOINT RESOLUTION 17-04-86-17  
WHICH APPROVED THE SUBMISSION OF A TRIBAL CHILD  
SUPPORT ENFORCEMENT GRANT TO THE UNITED STATES  
ADMINISTRATION FOR CHILDREN AND FAMILIES: OFFICE OF  
CHILD SUPPORT ENFORCEMENT FOR FY2018**

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected governing body of the Mille Lacs Band of Ojibwe (“Band”) a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and,
- WHEREAS, the Band Assembly and Chief Executive have established as a priority the improvement of spiritual, physical, mental, social and economic well-being of the people of the Mille Lacs Band; and,
- WHEREAS, the Band Assembly and Chief Executive recognize the importance and purpose of the established Child Support Enforcement for adequate support and nurturing of the children under the jurisdiction of the Band; and
- WHEREAS, the Band Assembly and Chief Executive fully support the goals of the Office of Child Support Enforcement; and
- WHEREAS, the granting agency increased the required match by \$2,353.00; and
- WHEREAS, the Band Assembly and Chief Executive recognize that the Band is required to commit cost sharing monies or in-kind resources in order to receive funding in the increased amount of not more than \$139,386.70 which is 20% of the total program funding of \$696,934.70.
- NOW, THEREFORE, BE IT RESOLVED that the Band Assembly and Chief Executive do hereby authorize and approve the match obligation and accept the funding from the United States Administration for Children and Families: Office of Child Support Enforcement for the purpose of obtaining grant funding for FY2018.




