RESOLUTION 18-01-162-18

**A RESOLUTION TO CANCEL A RESIDENTIAL LAND USE
AGREEMENT AUTHORIZED BY RESOLUTION 07-01-107-96 FOR
MILLE LACS BAND MEMBER [REDACTED]**

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution 07-01-107-96 authorized a residential land lease to Band Member [REDACTED] for the purpose of obtaining a lease site; and
- WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows:

(Tract E. Isle) That part of the SW1/4 of Section 1, Township 42, Range 25, Mille Lacs County, Minnesota, described as follows: Commencing at the Northeast corner of the W1/2 of NE1/4 of SW1/4 of said Section 1; thence West 450 feet to the point of beginning of the tract of land to be described; thence South 247.61 feet; thence West 150 feet; thence North 247.87 feet; thence East 150 feet to point of beginning. Subject to road easement over and above described property which lies Northerly of a line drawn from a point on the West line of the above described property therein a distance of 51.13 feet southerly of the Northwest corner to a point on the East line of the above described property therein distance 52.39 feet Southerly of the Northeast corner.

- WHEREAS, the home was demolished and lessee no longer resides at this lease site.
