## **JOINT RESOLUTION 18-02-178-18**

A JOINT RESOLUTION APPROVING THE MILLE LACS BAND OF OJIBWE'S PROPOSAL TO REQUEST FUNDING FOR A SPECIAL ASSISTANT UNITED STATES ATTORNEY THROUGH THE FIELD-INITIATED PROGRAMS TO IMPROVE OFFICER AND PUBLIC SAFETY FROM THE U.S. DEPARTMENT OF JUSTICE

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected governing body of the Mille Lacs Band of Ojibwe ("Band") a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Band Assembly and Chief Executive have established as a priority the improvement of spiritual, physical, mental, social and economic wellbeing of the people of the Band; and
- WHEREAS, the Band Assembly and Chief Executive recognize that the Office of Solicitor General and Tribal Police Department are responsible to provide law enforcement and public safety on the Mille Lacs Reservation; and
- WHEREAS, the Band Assembly and Chief Executive recognizes that the Office of the Solicitor General ("OSG") provides legal advice and representation for the Band Tribal Government and oversees the Tribal Police Department; and
- WHEREAS, the Band Assembly and Chief Executive fully support OSG representation of the Band in tribal, state and federal courts on all legal matters, including Indian Child Welfare, corporate law, family, and federal law; and
- WHEREAS, the Band Assembly and Chief Executive recognize that there are no cost sharing requirements with the submission.
- NOW, THEREFORE, BE IT RESOLVED that the Band Assembly and Chief Executive do hereby authorize and approve the Band's proposal to request funding for a Special Assistant United States Attorney through the Field-Initiated Programs to Improve Officer and Public Safety (CFDA-16.738) from The U.S. Department of Justice.
