JOINT RESOLUTION 17-04-13-18

A JOINT RESOLUTION APPROVING THE PARTICIPATION PLAN FOR THE MILLE LACS BAND OF OJIBWE'S USE OF THE MINNESOTA STATE ARMER RADIO SYSTEM

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected governing body of the Mille Lacs Band of Ojibwe ("Band") a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Band Assembly and Chief Executive have established as a priority the improvement of spiritual, physical, mental, social and economic wellbeing of the people of the Band; and
- WHEREAS, the Band currently has a contract with Mille Lacs County to use or access the State ARMER System in which the Mille Lacs Public Safety has limited use and access; and
- WHEREAS, the Mille Lacs Tribal Police Department requests that the Band enter into a participation plan for the use of the Minnesota State ARMER Radio System ("Plan") in order to eliminate the need to contract with Mille Lacs County and to give the Band dedicated ARMER radio channels to use within its departments across Districts I, II, IIa, and III allowing the ability to communicate Band-wide via radio; and
- WHEREAS, the Plan will include all facets of the Band government for current and projected planning and will include twenty-three (23) dedicated radio channels for the Band departments including Tribal Police, DNR Wildfire, EMS/Clinics, HHS, Roads and Public Works, and Schools and Transportation; and
- WHEREAS, the Band Assembly and Chief Executive agree it is in the best interests of the Band to exercise its own plan with the Minnesota State ARMER Radio System.
