RESOLUTION 18-01-87-18

A RESOLUTION AUTHORIZING THE MILLE LACS CORPORATE VENTURES TO EXPEND FUNDS FROM FY2018 CAPITAL BUDGET FOR GRAND CASINO HINCKLEY HOTEL ROOM RENOVATIONS

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, the Band Assembly is authorized under 3 MLBSA sec. 2(b) to appropriate all Band revenue regardless of source; and

WHEREAS, the Band Assembly is also authorized under 3 MLBSA sec. 2(d) to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, the Commissioner of Corporate Affairs formally requested approval on January 18, 2018 to expend 2018 capital project funds for Hotel Room Renovations at Grand Casino Hinckley in the amount of: Seven hundred thirty-eight thousand dollars and no cents (\$738,000.00).

WHEREAS, the Commissioner of Corporate Affairs requests a reclassification of funds to open this new capital project from the following projects:


IGT Advantage Service Window (02-1211-18-03)	\$548,000.00
Scoping Services (02-8814-18-01)	\$100,000.00
Floor Coverings (02-8814-18-03)	\$ 40,000.00
Plumbing Upgrades (02-8814-18-06)	\$ 50,000.00

NOW, THEREFORE, BE IT RESOLVED, the Band Assembly hereby approves the Mille Lacs Corporate Ventures expenditure listed hereinabove from the 2018 Capital Budget.
