JOINT RESOLUTION 17-04-34-18

A JOINT RESOLUTION APPROVING THE REQUEST FOR THE MILLE LACS BAND TO JOIN THE CENTRAL REGION RADIO BOARD

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected governing body of the Mille Lacs Band of Ojibwe (“Band”) a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Band Assembly and Chief Executive have established as a priority the improvement of spiritual, physical, mental, social and economic wellbeing of the people of the Band; and
- WHEREAS, the Band is currently a member of the Minnesota Northeast Region Radio Board; and
- WHEREAS, on October 31, 2017 Joint Resolution 17-04-13-18 approved the ARMER Participation Plan (“Plan”) for the Band’s use of the Minnesota State ARMER Radio System; and
- WHEREAS, the Central Region Radio Board has requested the Band become a member of their board upon approval of the Plan; and
- WHEREAS, the Band will continue to be a member and participate on both the Central and Northeast Regional Radio boards, as well as have usage and a chair at each Board; and
- WHEREAS, the Band Assembly and Chief Executive recognize that the Band’s Tribal Police Department will pay the fee to the radio board; and
- WHEREAS, the Band Assembly and Chief Executive recognize the importance of moving forward with the Plan and support joining the Central Region Radio Board.


