**RESOLUTION 18-01-155-18**

**A RESOLUTION TO CANCEL RESOLUTION 16-02-28-15 FOR MILLE LACS BAND MEMBER [REDACTED]**

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution 16-02-28-15 authorized a residential land lease with an attached mortgage to Band Member [REDACTED] for the purpose of obtaining a lease site; and
- WHEREAS, the land lease was to be for a period of 35 years and renewable for an additional 15 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows:
- Part of Tract #410T000222, located in Section Eighteen (18), Township Forty-one North (41N), Range Seventeen West (17W), Fourth Principal Meridian, Pine County, Minnesota, described as follows:
- Lot Nineteen (19), Block One (1) of Wise Owl Plat.
- WHEREAS, prior to signing the lease for the property described above, the lessee subleased an elder rental unit from the Band’s Housing Department, and no longer qualifies for this lease. This lease site should revert back to the Band.
- NOW, THEREFORE, BE IT RESOLVED, the Band Assembly hereby approves the cancellation of Resolution 16-02-28-15; and
