RESOLUTION 18-01-99-18

A RESOLUTION IN SUPPORT OF A MEMORANDUM OF UNDERSTANDING BETWEEN THE LEGISLATIVE, EXECUTIVE, AND JUDICIAL BRANCHES OF GOVERNMENT OF THE MILLE LACS BAND OF OJIBWE TO REVITALIZE THE MILLE LACS BAND JUSTICE SYSTEM

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Band has established as a priority the improvement of spiritual, physical, mental, social and economic well-being of the people of the Band; and
- WHEREAS, the Band collaborated with the Center for Court Innovation to conduct an expansive needs assessment of the Mille Lacs Band Justice System ("Justice System") from 2014 to 2017; and
- WHEREAS, the results of the assessment identified five problems that needed to be addressed within the Justice System; and
- WHEREAS, the Legislative, Executive, and Judicial branches of the Mille Lacs Band government recognize that culture and traditions of the Band, investing in Band youth, having the guidance of Band elders, engaging in the expertise of Band employees, strengthening awareness and communication with outside agencies, and promoting healing within the Band community is important to the revitalization of the Justice System; and
- WHEREAS, the Legislative, Executive, and Judicial branches of government wish to enter into a Memorandum of Understanding that outlines how the three branches of Band government will work together to improve the Justice System.
- NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly hereby supports the Memorandum of Understanding between the Legislative, Executive, and Judicial branches of the Mille Lacs Band to Revitalize the Mille Lacs Band Justice System.
