JOINT RESOLUTION 18-01-157-18

A JOINT RESOLUTION APPROVING A LIMITED WAIVER OF SOVEREIGN IMMUNITY IN THE EZFACILITY MASTER SUBSCRIPTION AGREEMENT

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, pursuant to 24 MLBSA § 2(b), the Court of Central Jurisdiction shall have exclusive original jurisdiction over all civil matters involving the Band or its entities to the Court of Central Jurisdiction unless by written contract, the Band consents to the jurisdiction of any other court or courts of competent jurisdiction and waives its sovereign immunity only to this extent, and the Band Assembly adopts a resolution ratifying the contract; and
- WHEREAS, the Band Assembly and Chief Executive desire to enter into a master subscription agreement ("Agreement") with EZFacility, Inc. for the gym management software at the Meshakwad Community Center located in Hinckley, Minnesota; and
- WHEREAS, all Mille Lacs Band of Ojibwe elected officials have acknowledged that governing law and venue and jurisdiction provisions granting a limited waiver of sovereign immunity are contained within the Agreement; and
- WHEREAS, the Band Assembly and Chief Executive hereby approve of the limited waiver of sovereign immunity contained in the Agreement.
- NOW THEREFORE BE IT RESOLVED, that the Band Assembly and Chief Executive approve the limited waiver of sovereign immunity contained in the EZFacility Master Subscription Agreement for services as described above.
