## **JOINT RESOLUTION 17-04-10-18**

## A JOINT RESOLUTION TO ADOPT THE FY 2018 MILLE LACS BAND TRIBAL TRANSPORTATION PROGRAM INVENTORY UPDATES

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Band Assembly and Chief Executive have established as a priority the improvement of the spiritual, physical, mental, social, and economic wellbeing of the people of the Band; and
- WHEREAS, transportation plays an integral role in serving local infrastructure and community needs; and
- WHEREAS, the Band desires to provide adequate transportation facilities to meet the needs of the residents of the Band; and
- WHEREAS, the Band is contracted under the provisions of P.L. 93-638 to conduct transportation planning activities in order to effectively use limited Tribal Transportation Program System Resources; and
- WHEREAS, these routes are important to general health, housing, and economic development opportunities of the residents of the Band.
