RESOLUTION 18-02-190-18

A RESOLUTION AUTHORIZING THE MILLE LACS CORPORATE VENTURES TO EXPEND ADDITIONAL FUNDS FROM FY2018 CAPITAL BUDGET FOR GRAND CASINO HINCKLEY SLOT MACHINE PURCHASES (H18-SLT-01)

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, the Band Assembly is authorized under 3 MLBSA sec. 2(b) to appropriate all Band revenue regardless of source; and

WHEREAS, the Band Assembly is also authorized under 3 MLBSA sec. 2(d) to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, Joseph Nayquonabe, Commissioner of Corporate Affairs formally requested approval on October 25, 2017 to expend 2018 capital project funds for slot machine purchases at Grand Casino Hinckley, and

WHEREAS, Resolution 17-04-16-18 was approved November 2, 2017 for slot machine purchases at Grand Casino Hinckley in the amount of \$2,459,807.00; and

WHEREAS, the Commissioner of Corporate Affairs requested approval on September 19, 2018 to expend an additional Three hundred sixty thousand dollars and no cents (\$360,000.00) to purchase 18 Aristocrat slot machine cabinets (Capital Project H18-SLT-01) for a total budget of \$2,819,807.00.

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the Mille Lacs Corporate Ventures expenditure listed hereinabove from the 2018 Capital Budget.


