RESOLUTION 18-01-133-18

A RESOLUTION APPROVING THE RELEASE OF LONG TERM SAVINGS FUNDS ON BEHALF OF MILLE LACS CORPORATE VENTURES FOR THE OWNER EQUITY AND CONTINGENCY COSTS ASSOCIATED WITH THE LADY LUCK ESTATES PROJECT

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally recognized Indian tribe (the "Band"); and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions; and
- WHEREAS, it is a priority of the Band Assembly to provide for the financial welfare of the Band and its members; and
- WHEREAS, Mille Lacs Corporate Ventures ("MLCV") is a corporate body politic of the Band pursuant to 16 MLBSA § 101; and
- WHEREAS, MLCV is constructing a new 28-unit townhome community in Hinckley, Minnesota ("Lady Luck Estates Project") and has requested Band Assembly to approve and authorize the release of funds for the Owner Equity and Contingency costs in the amount of \$2,300,000.00 ("Investment"); and
- WHEREAS, the Band Assembly has determined that it is in the best interest of the Band to make the Investment from funds held in the Band's long term savings.
- NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly approves the release of \$2,300,000.00 to MLCV by the Band with funds held in the Band's long term savings fund; and
- BE IT FURTHER RESOLVED, that the Chief Executive, on behalf of the Band, is hereby authorized to execute, deliver and cause the performance of the Investment, and any additional documents related thereto, that the Commissioner of Finance may determine as required to complete the Investment; and
- BE IT FURTHER AND FINALLY RESOLVED, that the Commissioner of Finance and appropriate personnel, agents and legal counsel of the Band are authorized and directed to administer the Investment in accordance with its terms and conditions.
