**RESOLUTION 18-01-89-18**

**A RESOLUTION AUTHORIZING THE MILLE LACS CORPORATE VENTURES TO EXPEND FUNDS FROM FY2018 CAPITAL BUDGET FOR GRAND CASINO HINCKLEY BUFFET EQUIPMENT**

WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and

WHEREAS, the Band Assembly is authorized under 3 MLBSA sec. 2(b) to appropriate all Band revenue regardless of source; and

WHEREAS, the Band Assembly is also authorized under 3 MLBSA sec. 2(d) to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, the Commissioner of Corporate Affairs formally requested approval on January 18, 2018 to expend 2018 capital project funds for buffet equipment at Grand Casino Hinckley in the amount of: Two hundred fifty-five thousand dollars and no cents (\$255,000.00).


WHEREAS, the Commissioner of Corporate Affairs requests to reallocate funds to complete this capital project from the following project(s):
