RESOLUTION 17-04-44-18

**A RESOLUTION TO CANCEL A RESIDENTIAL LAND LEASE
AUTHORIZED BY RESOLUTION 14-02-17-10 FOR MILLE LACS BAND
MEMBER [REDACTED]**

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution 14-02-17-10 authorized a residential land lease to Mille Lacs Band Member [REDACTED] for the purpose of obtaining a lease site; and
- WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows:

Part of Tract 410T001001. Beginning at the center of the Southeast Quarter, thence South a distance of 660 feet; thence East a distance of 990 feet, to the point of beginning; thence South a distance of 200 feet; thence East a distance of 125 feet; thence North a distance of 113 feet; thence Northwest parallel with U.S. Highway 169 to the point of beginning, in Section Seventeen (17), Township Forty-three North (43), Range Twenty-seven West (27). Fourth Principal Meridian. Mille Lacs County, Minnesota.

Said lease site containing 1.0 acres, more or less; and

NOW, THEREFORE, BE IT RESOLVED, the Band Assembly hereby approves the cancellation of Resolution 14-02-17-10; and

BE IT FURTHER AND FINALLY RESOLVED that the lease site will revert back to the Band.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 28th day of November, 2017 at Aazhoomog, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
