JOINT RESOLUTION 18-02-182-18

**A JOINT RESOLUTION APPROVING THE 2019 MEMBERSHIP INTO
THE NATIONAL INDIAN GAMING ASSOCIATION**

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBSA § 2 (a) and (d), the Band Assembly has the power to enact laws which regulate internal and external affairs of the Band in order to promote the general welfare of the people of the Band, and to adopt resolutions; and


WHEREAS, pursuant to 4 MLBSA § 6, the Chief Executive has the power to exercise the executive powers of Band government; and

WHEREAS, the Band wishes to remain a member tribe in good standing with the National Indian Gaming Association (“NIGA”).

NOW, THEREFORE, BE IT RESOLVED, that tribal funds in the amount of \$25,000.00 (twenty-five thousand dollars and no cents) based on the gross gaming revenue is authorized for payment for such membership in NIGA; and

BE IT FURTHER AND FINALLY RESOLVED, that the Band Assembly and Chief Executive do hereby authorize: Melanie Benjamin, Chief Executive; Sheldon Boyd, Secretary-Treasurer; Sandra Blake, District I Representative; Marvin Bruneau, District II Representative; and Wallace St. John Sr., District III Representative to become members in good standing in order to fulfill their responsibilities as Official Delegates and Alternate Delegates to the National Indian Gaming Association.
