JOINT RESOLUTION 18-02-06-19

A JOINT RESOLUTION APPROVING THE SUBMISSION OF A GRANT APPLICATION TO THE BUSH FOUNDATION - COMMUNITY INNOVATION GRANT PROGRAM

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Band Assembly and Chief Executive have established as a priority the improvement of the spiritual, physical, mental, social, and economic wellbeing of the people of the Band; and
- WHEREAS, the Band Assembly and Chief Executive recognize the need to offer adequate health and fitness programming to the Band and Community members; and
- WHEREAS, the Band Assembly and Chief Executive fully support the Bush Foundations mission to invest in people and organizations working on any issue that is important to their communities.
- NOW, THEREFORE, BE IT RESOLVED that the Band Assembly and Chief Executive do hereby authorize and approve the submission of a grant application to the Bush Foundation Community Innovation Grant Program.
