RESOLUTION 18-03-50-19

**A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED
BY RESOLUTION 13-03-62-09 FOR MILLE LACS BAND MEMBER
[REDACTED] ON TRACT 410T001039 f/k/a TRACT 410TF000108**

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution 13-03-62-09 authorized a residential land lease with an attached mortgage to Band Member [REDACTED] for the purpose of obtaining a lease site; and
- WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows: Part of Tract 410TF000108, n/k/a 410T001039 located in the North one-half (N½) of the Northwest one-quarter (NW ¼) of Section Twenty (20), Township Forty-three North (T43N), Range Twenty-seven West (27W), Mille Lacs County, Fourth Principal Meridian, more particularly described as follows:
- Lot One (1), Block nine (9) of Bugg Hill West Plat. The lease site is approximately 1 acre, more or less.
- WHEREAS, the lessee voluntarily relinquishes his land lease authorized by tribal Resolution 13-03-62-09 and requests this lease site revert back to the Band.
