
A RESOLUTION APPROVING THE CONTINUANCE OF THE MILLE LACS BAND HOUSING INITIATIVE FISCAL OPERATIONS UNTIL DECEMBER 31, 2018

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected governing body for the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(b) and (d), the Band Assembly has the authority to appropriate all Band revenue regardless of source, and adopt resolutions; and
- WHEREAS, 3 MLBSA § 18 requires that all fiscal operations under the jurisdiction of the Band shall cease as of midnight on the last day of the biennium, unless the Band Assembly adopts a continuing resolution prior to such time; and
- WHEREAS, Band Appropriation Bill 18-01-13-18, to fund the operations of the Housing Initiative for Fiscal Year 2018, expired September 30, 2018; and
- WHEREAS, the Band Assembly agrees to adopt a second continuing resolution until December 31, 2018.
- NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorize the continuance of the Band Housing Initiative fiscal operations until December 31, 2018.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 29th day of November, 2018 at Minneapolis, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
