JOINT RESOLUTION 18-02-23-19

A JOINT RESOLUTION APPROVING THE LICENSING OF BRIGHT BEGINNINGS ACADEMY INCORPORATED FOR THE OPERATION OF A DROP-IN CHILD CARE CENTER AT GRAND CASINO MILLE LACS AND GRAND CASINO HINCKLEY

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, on December 13, 2018, pursuant to 8 MLBSA §§ 946(d), 954(a), the Child Care Licensing Committee made a recommendation to Band Assembly to approve the application for Bright Beginnings Academy Inc. to operate drop-in child care centers in Grand Casino Mille Lacs and Grand Casino Hinckley for one year.
- NOW, THEREFORE, BE IT RESOLVED, the Band Assembly and Chief Executive hereby approve the licensing of the drop-in child care centers known as "Bright Beginnings Academy Inc." operating at Grand Casino Mille Lacs and Grand Casino Hinckley until December 13, 2019 as well as approve the continuation of the variance request allowing a child to attend the drop-in child care center for more than 90 hours in a month.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present, held on the 13th day of December, 2018 at Minisinaakwaang, Minnesota by a vote of 3 FOR, 0 AGAINST, SILENT.
