JOINT RESOLUTION 18-04-115-19

**A JOINT RESOLUTION IN SUPPORT OF THE APPOINTMENT OF
LINDSAY MISQUADACE-BERG TO THE AMERICAN INDIAN
MENTAL HEALTH ADVISORY COUNCIL**

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and

WHEREAS, the Band Assembly and Chief Executive recognize the need to have representation on the American Indian Mental Health Advisory Council; and

WHEREAS, the Band Assembly and Chief Executive do hereby name Lindsay Misquadace-Berg, Director of Four Winds Lodge Treatment Program for the Band, to attend and participate in all American Indian Mental Health Advisory Council meetings on behalf of the Band; and

WHEREAS, all materials or information obtained at the meetings shall be completely and factually distributed to Elected Officials and department heads as it pertains to Mental Health, Chemical Dependency, and Social Services programs within the Band and to comply with all necessary reporting requirements.

NOW, THEREFORE, BE IT RESOLVED that the Band Assembly and Chief Executive hereby appoint Lindsay Misquadace-Berg to represent the Mille Lacs Band of Ojibwe on the American Indian Mental Health Advisory Council.

WE DO HEREBY CERTIFY that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council, a quorum of legislators being present held on the 27th day of August, 2019 at Minneapolis, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.




