RESOLUTION 18-02-13-19

**A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED
BY RESOLUTION 14-03-20-11 FOR MILLE LACS BAND MEMBER**

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution 14-03-20-11 authorized a residential land lease with an attached mortgage to Band Member [REDACTED] for the purpose of obtaining a lease site; and
- WHEREAS, the land lease was to be for a period of 30 years and renewable for an additional 20 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows:

Part of Tract 410T1030, located in that part of Government Lot 7, Section Eighteen (18), Township Forty-three (43N) North, Range Twenty-seven (27W) West, Fourth Principal Meridian, Mille Lacs County, Minnesota described as follows:

Parcel D

Commencing at the Northeast corner of said Government Lot 7; thence North 89 degrees 45 minutes 26 seconds West 429.96 feet; thence South 0 degrees 14 minutes 34 seconds West 403.00 feet; thence North 89 degrees 45 minutes 26 seconds West 400.00 feet to the point of beginning of the tract of land to be described; thence North 89 degrees 45 minutes 26 seconds West 200.00 feet; thence North 0 degrees 14 minutes 34 seconds East 200.00 feet; thence South 89 degrees 45 minutes 26 seconds East 200.00 feet; thence South 0 degrees 14 minutes 34 seconds West 200.00 feet to the point of beginning. This lease site is 1 acre more or less. Central Minnesota Surveying Inc. Survey Job #985927 Dated 9/15/98.


WHEREAS, the lessee voluntarily relinquishes her land lease authorized by tribal resolution 14-03-20-11 and requests this lease site revert back to the Band.
