JOINT RESOLUTION 18-02-15-19

**A JOINT RESOLUTION IN SUPPORT OF THE APPOINTMENT OF
KELLY APPEGATE AND BRADLEY HARRINGTON TO THE TRIBAL
WILD RICE TASK FORCE**

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected governing body of the Mille Lacs Band of Ojibwe (“Band”) a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Band Assembly and Chief Executive have established as a priority the improvement of spiritual, physical, mental, social and economic wellbeing of the people of the Band; and
- WHEREAS, the Tribal Executive Committee established the Tribal Wild Rice Task Force, via Resolution 107-18, which will be comprised of two representatives from each tribe who wish to participate; and
- WHEREAS, the Band supports Kelly Applegate and Bradley Harrington to be the two representatives on the Task Force; and
- WHEREAS, Kelly Applegate and Bradley Harrington are both employed with the Natural Resources Department for the Band.
- NOW, THEREFORE, BE IT RESOLVED that the Band Assembly and Chief Executive hereby appoint Kelly Applegate and Bradley Harrington to represent the Band, as a member on the Wild Rice Task Force.


