A JOINT RESOLUTION TO SUPPORT THE SUBSTANCE ABUSE AND MENTAL HEALTH SERVICES ADMINISTRATION GRANT PROJECT WITH THE UNIVERSITY OF MINNESOTA EXTENSION

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected governing body of the Mille Lacs Band of Ojibwe ("Band") a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Band Assembly and Chief Executive have established as a priority the improvement of spiritual, physical, mental, social and economic well-being of the people of the Mille Lacs Band; and
- WHEREAS, the Band Assembly and Chief Executive recognize that the opioid issue affects people of all ages across the Mille Lacs Band districts and believe that it is necessary to address this issue in order to improve health and well-being of the people; and
- WHEREAS, the Band Assembly and Chief Executive fully support the Substance Abuse and Mental Health Services Administration ("SAMHSA") grant project, including all tribal divisions and departments, to work in partnership with the University of Minnesota Extension, (including the Center for Family Development and Community Vitality), and the University of Minnesota College of Pharmacy-Duluth; and
- WHEREAS, in partnership with the University of Minnesota and in collaboration with numerous divisions of the Band and members of the community, a menu of inperson and online resources will be developed, including training and technical assistance, to work on addressing the opioid issue; and
- WHEREAS, the Band Assembly and Chief Executive recognize that there are no cost sharing requirements for partnering with this project.
