JOINT RESOLUTION 18-03-97-19

A JOINT RESOLUTION TO APPROVE THE REVISED PUBLIC LAW 102-477 MASTER PLAN FOR THE MILLE LACS BAND OF OJIBWE FOR THE TIME PERIOD BEGINNING OCTOBER 1, 2019 THROUGH **SEPTEMBER 30, 2022**

- the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing WHEREAS, body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- pursuant to 3 MLBSA § 2(d), the Band Assembly has the power to adopt WHEREAS, resolutions to promote the general welfare of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive is empowered to exercise the Executive Branch powers of the Band; and
- the Band Assembly and Chief Executive have established as a priority the WHEREAS, improvement of the spiritual, physical, mental, social, and economic wellbeing of the people of the Band; and
- the goal of the Band is to promote the general welfare of Band members by WHEREAS, providing training, employment, counseling and other opportunities to obtain economic self-sufficiency for tribal members; and
- WHEREAS, the purpose of the proposed P.L. 102-477 Plan is to identify how the Tribe and Agnitibima adizing will deliver services to participants, which includes TANF; and
- WHEREAS, the proposed P.L. 102-477 Plan is to provide employment and training related services for the next three year cycle, beginning October 1, 2019 through September 30, 2022.
- NOW THEREFORE BE IT RESOLVED, the Band Assembly and Chief Executive do hereby approve the revised Public Law 102-477 Master Plan, a copy of which is attached hereto as Exhibit A.
