## **RESOLUTION 18-03-95-19**

## A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED BY RESOLUTION 14-01-103-10 TO MILLE LACS BAND HOUSING DEPARTMENT ON TRACT 410TF000264

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution 14-01-103-10 authorized a residential land lease for the purpose of obtaining a lease site; and
- WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows:

  Tract No. 410TF000264, described as Lots Eight (8), Nine (9), and Ten (10),
  Block Nine (9), Port Mille Lacs, Gold Acres North, Fourth Principle Meridian,
  Mille Lacs County, Minnesota.

This lease site is one acre, more or less.

- WHEREAS, the lessee voluntarily relinquishes the land lease authorized by tribal Resolution 14-01-103-10 and requests this lease site revert back to the Band.
- NOW, THEREFORE, BE IT RESOLVED, the Band Assembly hereby approves the cancellation of Resolution 14-01-103-10; and

BE IT FURTHER AND FINALLY RESOLVED that the lease site will revert back to the Band.
