JOINT RESOLUTION 18-02-21-19

A JOINT RESOLUTION APPROVING THE SUBMISSION OF A GRANT PROPOSAL TO THE MINNESOTA DEPARTMENT OF HEALTH FOR THE MINNESOTA EVIDENCE BASED HOME VISITING PROGRAM

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected governing body of the Mille Lacs Band of Ojibwe (“Band”) a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and

WHEREAS, the Band Assembly and Chief Executive have established as a priority the improvement of spiritual, physical, mental, social and economic well-being of the people of the Band; and

WHEREAS, the Band Assembly and Chief Executive recognize and support the goals of the Minnesota Department of Health Evidenced Based Home Visiting Program in providing, women, parents and other caregivers with the knowledge, skills and tools to achieve a healthy birth and assist their children in being physically, socially, and emotionally healthy, safe and ready to succeed in school; and

WHEREAS, the Band Assembly and Chief Executive recognize that this grant proposal is a collaboration between the Band, Mille Lacs County Community and Veteran Services, and Pine County Health and Human Services; and

WHEREAS, the Band Assembly and Chief Executive recognize that there are no cost sharing requirements to obtain the funding.

NOW, THEREFORE, BE IT RESOLVED that the Band Assembly and Chief Executive do hereby authorize and approve the submission of the grant proposal to the Minnesota Evidence Based Family Home Visiting Program through the Minnesota Department of Health.


