RESOLUTION 18-02-09-19

A RESOLUTION AUTHORIZING THE MILLE LACS CORPORATE VENTURES TO EXPEND FUNDS FROM FY2019 CAPITAL BUDGET FOR GRAND CASINO HINCKLEY, SYSTEMS – EQUIPMENT REPLACEMENT (02-6014-19-01)

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, the Band Assembly is authorized under 3 MLBSA sec. 2(b) to appropriate all Band revenue regardless of source; and

WHEREAS, the Band Assembly is also authorized under 3 MLBSA sec. 2(d) to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, Joseph S. Nayquonabe, Commissioner of Corporate Affairs, formally requested approval on October 19, 2018 to open a 2019 capital project for Systems – Equipment Replacement (02-6014-19-01) at Grand Casino Hinckley in the amount of: Two hundred seventy-one thousand dollars and no cents (\$271,000.00).

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the Mille Lacs Corporate Ventures expenditure listed hereinabove from the 2019 Capital Budget.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 1st day of November, 2018 at Aazhoomog, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
