A JOINT RESOLUTION DENYING THE ENROLLMENTS INTO THE MILLE LACS BAND, MILLE LACS RESERVATION FOR THOSE WHO DO NOT MEET THE REQUIREMENT OF THE MINNESOTA CHIPPEWA TRIBE CONSTITUTION BORN FROM AN ENROLLED MILLE LACS BAND MEMBER

WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBSA § 2(d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the Band; and

WHEREAS, pursuant to 4 MLBSA § 6, the Chief Executive is empowered to exercise the Executive Branch powers of the Band; and

WHEREAS, the Band Assembly and Chief Executive have reviewed the following applications for enrollment:

- NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly and Chief Executive denies the above applicants for enrollment, they do not meet the requirements found in Article II of the Minnesota Chippewa Tribal Constitution.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 28<sup>th</sup> day of January, 2020 at Minneapolis, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
