RESOLUTION 19-02-160-20

A RESOLUTION APPROVING A LICENSE TO OPERATE WEWINABI, HEAD START AND EARLY HEAD START IN DISTRICTS I, II AND III

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected legislative body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (a) and (d), the Band Assembly has the power to enact laws which regulate internal and external affairs of the Band in order to promote the general welfare of the people of the Band, and to adopt resolutions; and
- WHEREAS, pursuant to 4 MLBSA § 6, the Chief Executive has the power to exercise the executive powers of Band government; and
- WHEREAS, the Band Assembly acknowledges that a statutory amendment regarding the licensing of child care centers on Band Lands has been adopted by the Band Assembly on October 1, 2013 and such Ordinance is numbered 49-13; and
- WHEREAS, the Mille Lacs Band child care centers in Districts I, II & III had a license adopted via Joint Resolution 18-04-116-19 and such license expires on September 30, 2020; and
- WHEREAS, on September 28, 2020 the Licensing Committee recommends to continue the licensure of Wewinabi, Head Start and Early Head Start in Districts I, II and III; and
- WHEREAS, the District I Wewinabi has a capacity of Infants: 24-32; Toddlers: 72-84; Preschool: 98; and School Age: 35; and
- WHEREAS, the District II has a capacity of Infants/Toddlers-16; and Preschool-18; and
- WHEREAS, the District III has a capacity of Infants/Toddlers-8; and Preschool-18.
