RESOLUTION 18-04-126-19

A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED BY RESOLUTION 18-01-147-18 FOR THE MILLE LACS BAND HOUSING DEPARTMENT

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution 18-01-147-18 authorized a residential land lease for the purpose of obtaining a lease site; and
- WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS. said land is described as follows:

Part of Tract 410TF000181, located in the Southwest Quarter of the Southeast Quarter (SW1/4 of SE1/4) of Section Twenty-three (23), Township Forty-seven North (47N), Range Twenty-seven West (27W), Fourth Principle Meridian, Aitkin County, Minnesota, more particularly described as follows:

Lots One (1) and Two (2) of Block Seventy (70) of Hungerford's Addition to Aitkin, excepting a tract described as follows: All of the East 2 feet of said Lot Two (2) excepting the North 75 feet of said East 2 feet of said Lot Two (2) of Hungerford's Addition to Aitkin, according to the filed plat thereof.

Lease site contains 0.16 acres, more or less.

the lessee voluntarily relinquishes her land lease authorized by tribal resolution 18-WHEREAS, 01-147-18 and requests this lease site revert back to the Band.
