**JOINT RESOLUTION 18-04-125-19**

**A JOINT RESOLUTION DENYING THE ENROLLMENTS INTO THE MILLE LACS BAND, MILLE LACS RESERVATION FOR THOSE WHO DO NOT MEET THE REQUIREMENT OF THE MINNESOTA CHIPPEWA TRIBE CONSTITUTION BORN FROM AN ENROLLED MILLE LACS BAND MEMBER**

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 6, the Chief Executive is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Band Assembly and Chief Executive have reviewed the following applications for enrollment:

- WHEREAS, the Mille Lacs Band Assembly has reviewed Article II-Membership of the Revised Constitution and By-laws of the Minnesota Chippewa Tribe.
- WHEREAS, the Band Assembly and Chief Executive agree the individuals do not meet the requirement, born from an enrolled Mille Lacs Band Member, for enrollment into the Mille Lacs Band.
- NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly and Chief Executive denies the above applicants for enrollment, they do not meet the requirements found in Article II of the Minnesota Chippewa Tribal Constitution.




