RESOLUTION 19-01-94-20

**A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED
BY RESOLUTION 11-03-68-05 FOR MILLE LACS BAND MEMBERS**

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution 11-03-68-05 authorized a residential land lease to Band Members [REDACTED] for the purpose of obtaining a lease site; and
- WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows:

Part of Tract #410T001040; described as the Southwest Quarter of the Northeast Quarter (SW1/4 of NE1/4), Section One (1), Township Forty-two (42) North, Range Twenty-five (25) West more particularly described as Tract 1 of the Comstock and Davis, Inc. Survey dated September 22, 1995. Containing one acre more or less.

f/k/a Part of Tract #410TF000178; described as being located in Section One (1), Township Forty-two North (T42N), Range Twenty-five West (R25W), Fourth Principal Meridian, Mille Lacs County, Minnesota, described as follows:

Tract Seven (7) of Comstock and Davis Survey, Job #950556.003

This lease site contains 1.0 acres, more or less.

WHEREAS, this lease site shall revert back to the Band.

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the cancellation of Resolution 11-03-68-05; and

BE IT FURTHER AND FINALLY RESOLVED that the lease site will revert back to the Band.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 13th day of February, 2020 at Chi Minising, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
