RESOLUTION 18-04-131-19

**A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED
BY RESOLUTION 11-02-23-05 FOR MILLE LACS BAND MEMBER
[REDACTED] TRACT 410T001001**

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution 11-02-23-05 authorized a residential land lease with an attached mortgage to Band Member [REDACTED] for the purpose of obtaining a lease site; and
- WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, Part of Tract 410T001001, located in the North half (N ½) of the Northeast Quarter (NE ¼) of Section Twenty (20), Township forty-three North (43N), Range Twenty-seven West (27W), Mille Lacs County, Fourth Principle Meridian, more particularly described as follows:
- Lot Forty-three (43), Bug Hill Plat
- WHEREAS, the lessee voluntarily relinquishes his land lease due to Deed of Lieu of Foreclosure authorized by tribal Resolution 11-02-23-05 and requests this lease site revert back to the Band.
- NOW, THEREFORE, BE IT RESOLVED, the Band Assembly hereby approves the cancellation of Resolution 11-02-23-05; and
- BE IT FURTHER AND FINALLY RESOLVED that the lease site will revert back to the Band.
