## **RESOLUTION 18-04-128-19**

A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED BY RESOLUTION 18-03-49-19 FOR THE MILLE LACS BAND HOUSING **DEPARTMENT TRACT 410T001017** 

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any WHEREAS, commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution 18-03-49-19 authorized a residential land lease for the purpose of obtaining a lease site; and
- WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows: Tract No. 410T001017, located in the Northeast Quarter of the Northwest Quarter (NE<sup>1</sup>/<sub>4</sub> of NW<sup>1</sup>/<sub>4</sub>) of Section Seventeen (17), Township Forty-seven North (47N), Range Twenty-three West (23W), Fourth Principle Meridian, Aitkin County, Minnesota, more accurately described as follows:

Commencing at a Global Positioning System (GPS) Coordinate (478,869.36; 5,156,564.18), thence South 0 degrees 00 minutes 00 seconds East a distance of 125.84 feet to the point of beginning of the tract to be described; thence continue South 0 degrees 00 minutes 00 seconds East a distance of 200.00 feet; thence South 90 degrees 00 minutes 00 seconds West a distance of 304.31 feet; thence North 0 degrees 00 minutes 00 seconds West 53.14 feet more or less to Global Positioning System (GPS) Coordinate (478,803.36; 5,156,482.34); thence North 14 degrees 37 minutes 15 seconds East a distance of 146.35 feet more or less to a point which lies South 90 degrees 00 minutes 00 seconds West from the point of beginning. (GPS Coordinates are Universal Transverse Mercator (UTM) Zone 15 NAD 83 Projection Points).
