RESOLUTION 18-04-127-19

A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED BY RESOLUTION 10-01-61-02 FOR THE MILLE LACS BAND HOUSING DEPARTMENT TRACT 410T001017

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution 10-01-61-02 authorized a residential land lease for the purpose of obtaining a lease site; and
- WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows:

 Tract No. 410T001017, located in the Northeast Quarter of the Northwest Quarter (NE¼ of NW¼) of Section Seventeen (17), Township Forty-seven North (47N), Range Twenty-three West (23W), Fourth Principle Meridian, Aitkin County, Minnesota, more accurately described as follows:

Commencing at a Global Positioning System (GPS) Coordinate (478,820.55; 5,156,548.22), the point of beginning, thence bearing South 14 degrees 37 minutes 15 seconds West a distance of 223.37 feet, thence South 90 degrees 0 minutes 0 seconds West a distance of 157.59 feet; thence North 0 degrees 22 minutes 60 seconds East a distance of 216.14 feet; thence South 90 dergees 0 minutes 0 seconds West a distance of 212.52 feet to GPS coordinate (478,897.27; 5,156,614.38), the point of beginning (GPS coordinates are Universal Transverse Mercator (UTM) Zone 15 NAD 83 Projection Points).

This lease site contains 1 acre, more or less.
