RESOLUTION 18-04-54-20

A RESOLUTION AUTHORIZING THE MILLE LACS CORPORATE VENTURES TO EXPEND FUNDS FROM FY2020 CAPITAL BUDGET FOR GRAND CASINO MILLE LACS AND GRAND CASINO HINCKLEY ENTERPRISE PURCHASING SYSTEM

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly is authorized under 3 MLBSA sec. 2(b) to appropriate all Band revenue regardless of source; and
- WHEREAS, the Band Assembly is also authorized under 3 MLBSA sec. 2(d) to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, Joseph S. Nayquonabe, Commissioner of Corporate Affairs, formally requested approval on January 6, 2020 to open a FY2020 capital project for Enterprise Purchasing System at Grand Casino Mille Lacs and Grand Casino Hinckley in the amount of: Three hundred fifty thousand dollars and no cents (\$350,000.00).
- NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the Mille Lacs Corporate Ventures expenditure listed hereinabove from the FY2020 Capital Budget.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 9th day of January, 2020 at Nayahshing, Minnesota by a vote of 3 FOR, O AGAINST, O SILENT.

Please accept this letter as a formal request to open a FY2020 capital project related to the purchase of a new Enterprise Purchasing System for Grand Casino Mille Lacs and Grand Casino Hinckley. The capital budget for this project is \$350,000.

The gaming facilities are currently using multiple platforms (Dataworks, Paramount and CBord) to accomplish various tasks for purchasing, inventory, recipe management, etc. None of the current platforms have the capability to be all inclusive of all needed capabilities. This project will bring a dynamic solution for purchase orders, inventory management, capital projects, recipe management, internal transfers, shipping and receiving, among other features. This capability will provide a more streamlined process for departments to use and share data.
