RESOLUTION 18-04-49-20

A RESOLUTION AUTHORIZING THE MILLE LACS CORPORATE VENTURES TO EXPEND FUNDS FROM FY2020 CAPITAL BUDGET FOR WEWINABI CAPITAL PROJECTS

WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and

WHEREAS, the Band Assembly is authorized under 3 MLBSA sec. 2(b) to appropriate all Band revenue regardless of source; and

WHEREAS, the Band Assembly is also authorized under 3 MLBSA sec. 2(d) to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, Joseph S. Nayquonabe, Commissioner of Corporate Affairs, formally requested an additional appropriation on January 6, 2020 to fund capital projects that were approved in FY2019 for:

ML Gas Paving Repairs \$ 27,345.47 Grand Makwa Fire Alarm \$ 5,515.01 ML Gas Spill Buckets \$ 13,656.41 Wewinabi Office HVAC \$ 7,800.00 Super Stop Mound System \$129,750.00

Total \$184,066.89: One hundred eighty-four thousand, sixty-six dollars and eighty-nine cents from FY2020 Economic Development Funds.

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the Mille Lacs Corporate Ventures expenditure listed hereinabove from the 2020 Capital Budget.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 7th day of January, 2020 at Nayahshing, Minnesota by a vote of 3 FOR, O AGAINST, O SILENT.
