RESOLUTION 19-02-137-20

A RESOLUTION TO MODIFY RESOLUTION 06-04-148-95 WHICH AUTHORIZED A LAND LEASE FOR RESIDENTIAL PURPOSES TO THE MILLE LACS BAND HOUSING DEPARTMENT

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution 06-04-148-95 authorized land leases to the Mille Lacs Band Housing Department for the purpose of establishing homesites; and
- WHEREAS, the leases are for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective September 8, 1995, for the properties described in Resolution 06-04-148-95; and
- WHEREAS, the property was accepted into trust on August 28, 2019, and assigned a trust tract by the United States of America for the Mille Lacs Band of Minnesota Chippewa Tribe, Minnesota; and
- WHEREAS, the Lease description in Resolution 06-04-148-95 should be modified to reflect the correct legal description for the trust tract and recorded with the BIA to reflect on encumbrance of trust land; and
- WHEREAS, said Lease description is described in Resolution #06-04-148-95 as follows:

Part of Tract 410 TF 56, located in the Southwest Quarter of the Southwest Quarter (SW¼ SW¼) of Section Twenty-one (21), Township Forty-three North (43N), Range Twenty-seven West (27W), Kathio Township, Mille Lacs County, Mille Lacs Reservation, Fourth Principle Meridian, further described as:

WHEREAS, said lease description is to be modified to be described as follows:

Part of Tract 410T001051, Government Lot Four (4) and the Southwest Quarter of the Southwest Quarter (SW¹/₄ SW¹/₄) of Section Twenty-one (21), Township Forty-three North (43N), Range Twenty-seven West (23W), Fourth Principle Meridian, Mille Lacs County, Minnesota, described as follows:

Lot Two (2), Block One (1) of North Connection Plat, containing one acre, more or less.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly hereby authorizes modification of Resolution 06-04-148-95, to re-define the legal description. All other terms and conditions shall remain the same.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 26th day of August, 2020 at Nayahshing, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.

- 08/28/2019: The Drumsta property was accepted into trust;
- 08/28/2019: The tract number changed when the BIA assigned a trust tract and all leases need to be filed with the BIA to reflect the encumbrance on trust lands.
- 08/03/2020: Resolution to Modify 06-04-148-95 is submitted to Band Assembly for approval.
