RESOLUTION 19-02-136-20

**A RESOLUTION TO MODIFY RESOLUTION 10-03-37-03 WHICH
AUTHORIZED A LAND LEASE FOR RESIDENTIAL PURPOSES TO
THE MILLE LACS BAND HOUSING DEPARTMENT**

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution 10-03-37-03 authorized land leases to the Mille Lacs Band Housing Department for the purpose of establishing homesites; and

WHEREAS, the leases are for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective March 4, 2008, for the properties described in Resolution 10-03-37-03; and

WHEREAS, the property was accepted into trust on August 28, 2019, and assigned a trust tract by the United States of America for the Mille Lacs Band of the Minnesota Chippewa Tribe, Minnesota; and

WHEREAS, the Lease description in Resolution 10-03-37-03 should be modified to reflect the correct legal description of the trust tract and recorded with the BIA to reflect the encumbrance of trust land; and

WHEREAS, said Lease description is described in Resolution #10-03-37-03 as follows:

Part of Tract 410 TF 56, located in the Southwest Quarter of the Southwest Quarter (SW¼ SW¼) of Section Twenty-one (21), Township Forty-three North (43N), Range Twenty-seven West (27W), Kathio Township, Mille Lacs County, Mille Lacs Reservation, Fourth Principle Meridian, further described as:

WHEREAS, said lease description is to be modified to be described as follows:

Part of Tract 410T001051, Government Lot Four (4) and the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$ SW $\frac{1}{4}$) of Section Twenty-one (21), Township Forty-three North (43N), Range Twenty-seven West (23W), Fourth Principle Meridian, Mille Lacs County, Minnesota, described as follows:

Lot Thirteen (13), Block One (1) of North Connection Plat, containing one acre, more or less.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly hereby authorizes modification of Resolution 10-03-37-03, to re-define the legal description. All other terms and conditions shall remain the same.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 26th day of August, 2020 at Nayahshing, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
