#### **JOINT RESOLUTION 18-04-20-20**

A JOINT RESOLUTION AMENDING 18-04-111-19 TO REFLECT THE CORRECT DOLLAR AMOUNT FOR THE SUBMISSION OF A TRIBAL CHILD SUPPORT ENFORCEMENT GRANT TO THE UNITED STATES ADMINISTRATION FOR CHILDREN AND FAMILIES: OFFICE OF CHILD SUPPORT ENFORCEMENT FOR FY2020

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected governing body of the Mille Lacs Band of Ojibwe ("Band") a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Band Assembly and Chief Executive have established as a priority the improvement of spiritual, physical, mental, social and economic well-being of the people of the Band; and
- WHEREAS, Joint Resolution 18-04-111-19 was approved on August 13, 2019 and reads:

the Band Assembly and Chief Executive recognize that the Band is required to commit cost sharing monies or in-kind resources in order to receive funding in the amount of \$720,596.56 of which \$144,876.68 or 20% is the required match; and

WHEREAS, a request was made to correct the Joint Resolution to reflect the correct funding and cost share/match amount and should now read:

the Band Assembly and Chief Executive recognize that the Band is required to commit cost sharing monies or in-kind resources in order to receive funding in the amount of \$721,824.57 of which \$144,387.64 or 20% is the required match.

NOW, THEREFORE, BE IT RESOLVED that the Band Assembly and Chief Executive do hereby authorize and approve the amendment to Joint Resolution 18-04-111-19 to reflect the correct funding and cost share/match amount as submitted for the submission of a Tribal Child Support Enforcement Grant to the United States Administration for Children and Families: Office of Child Support Enforcement for the purpose of obtaining grant funding for FY2020.
