## **RESOLUTION 19-02-131-20**

## A RESOLUTION AUTHORIZING A CHARTER SCHOOL LEASE TO MINISINAAKWAANG LEADERSHIP ACADEMY

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, a business lease is being requested by Minisinaakwaang Leadership Academy ("MLA"), a non-profit organization; and
- WHEREAS, the subject lease is requested for the purpose of operating a Kindergarten through 12<sup>th</sup> Grade Charter School under the laws and requirements of the State of Minnesota located on the property described herein; and
- WHEREAS, the lease is requested for a period of three (3) years, subject to the lease provisions, effective upon approval; and
- WHEREAS, the lease will consist of the space identified on the attached map for the District II Community Center located on part of Tract 410T1031; and
- WHEREAS, the legal description is more specifically described as:

  Part of Tract # 410 T 1031 where the District II Community Center is located is described as the South Half of the Northwest Quarter (S½ of NW¼) of Section 20 Township 47 North Range 23 West, 4<sup>th</sup> Principal Meridian, Aitkin County, Minnesota; and
- WHEREAS, the attached map defines the area the MLA is leasing along with its non-exclusive use of common areas in the District II Community Center; and
- WHEREAS, the MLA will also have non-exclusive use of the grounds surrounding the District II Community Center for the purposes of parking and outdoor educational activities; and
